



# 2010 Michigan Community Hershey Track & Field Games Entry Form

The time to sign up for the Hershey Track & Field Games is **NOW!** This entry form will help to expedite the sign up process and allow us to send important materials to you early. The Hershey Program, for youth 9 - 14 years of age, promises to be bigger and better than ever. The state meet will be held in Holt **on Friday, July 9**, and will once again include events for the "physically challenged."

In order to participate in the Hershey Program you must:

1. Submit entry form with the \$40 entry fee to the MRPA office no later than **April 30, 2010** (make check payable to "MRPA"). There is no guarantee that entry forms will be accepted after this date. However, should an entry form be accepted after this date, an automatic late fee of \$20 would be assessed. No refunds of Hershey Track & Field Games entry fees after **May 14, 2010**. Any refunds issued prior to May 14, 2010 shall be assessed a \$10 administrative fee.
2. Hold a local qualifying meet to determine your representatives for the state meet. Complete and return rosters to the MRPA office by **June 21, 2010**. Local meets must be held early enough to have rosters submitted by this date.
3. Attend the MRPA Summer Mandatory Athletic Meeting. Failure to attend may disqualify your community from the state meet. The Mandatory Meeting will be held on Friday, June 25 at 10 a.m. at Delta Township's Community Center (7550 West Willow).
